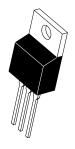

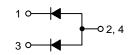

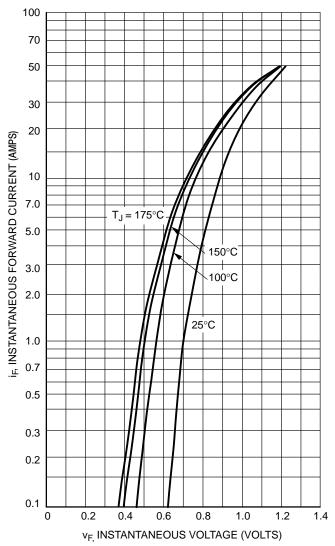


Figure 1. Typical Forward Voltage (Per Leg)

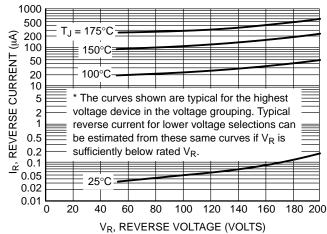


Figure 2. Typical Reverse Current* (Per Leg)

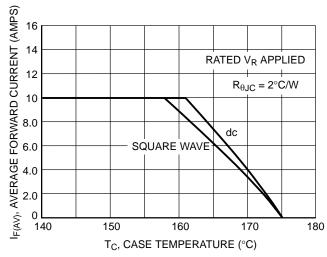
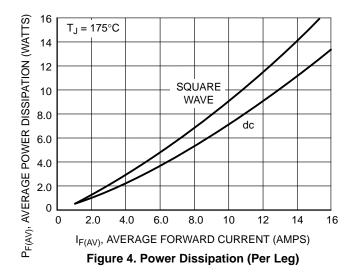


Figure 3. Current Derating, Case (Per Leg)



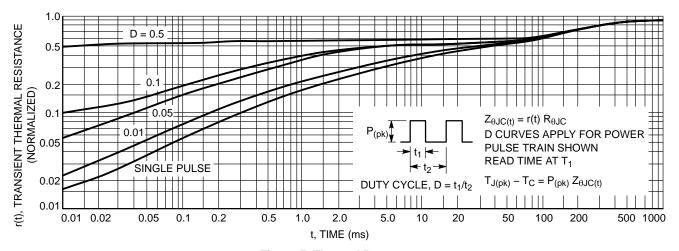


Figure 5. Thermal Response

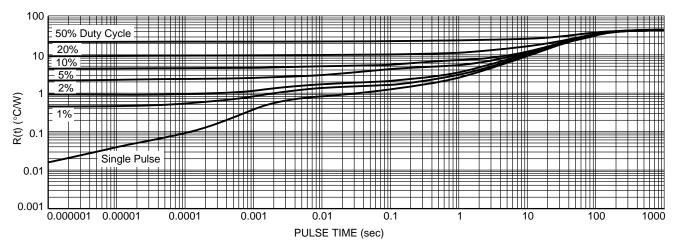


Figure 6. Thermal Response, Junction-to-Ambient

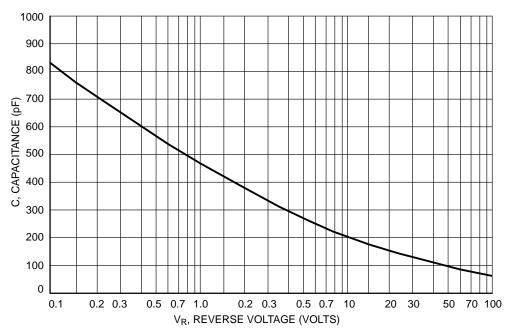
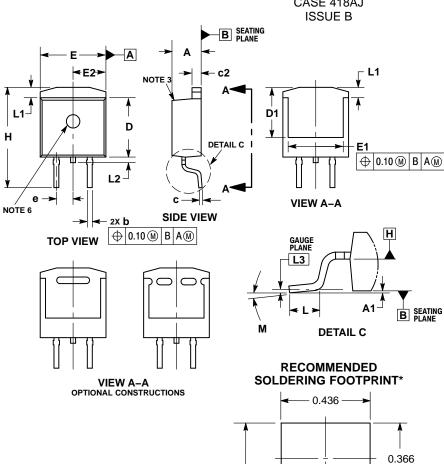


Figure 7. Typical Capacitance (Per Leg)

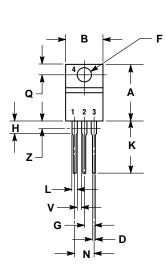

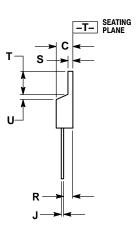
