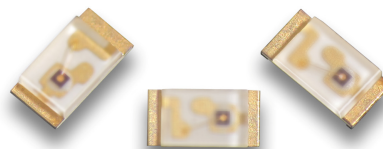


## APG1608SYKC/T 1.6 x 0.8 x 0.25 mm (0603) SMD Chip LED Lamp

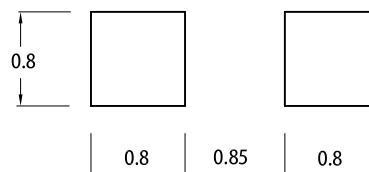

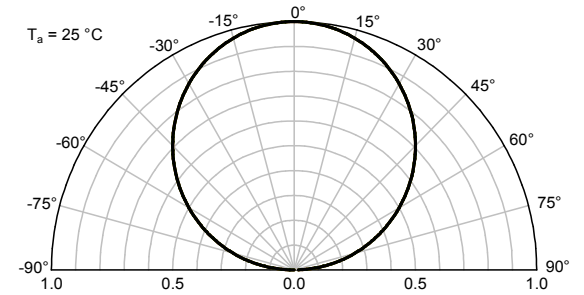

### RELATIVE INTENSITY vs. WAVELENGTH

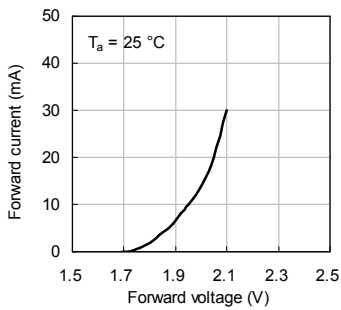


### SPATIAL DISTRIBUTION

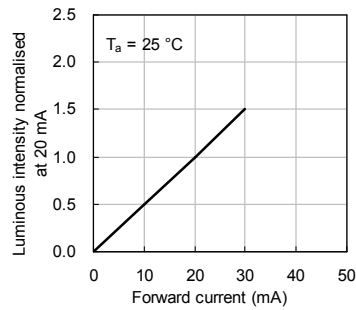

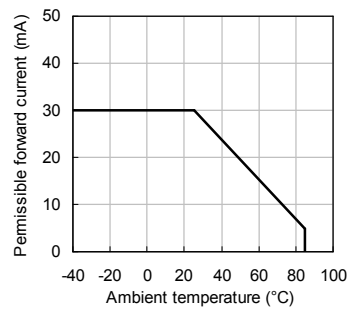
Forward Current vs. Forward Voltage



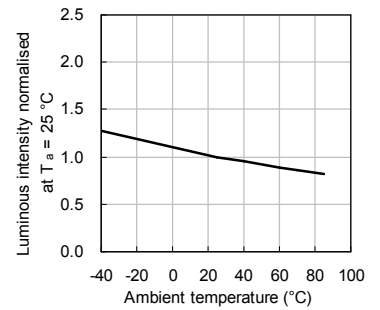
Luminous Intensity vs. Forward Current



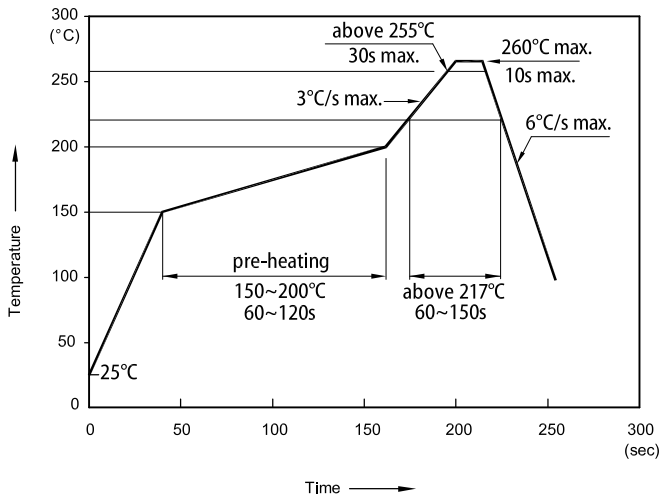
Forward Current Derating Curve



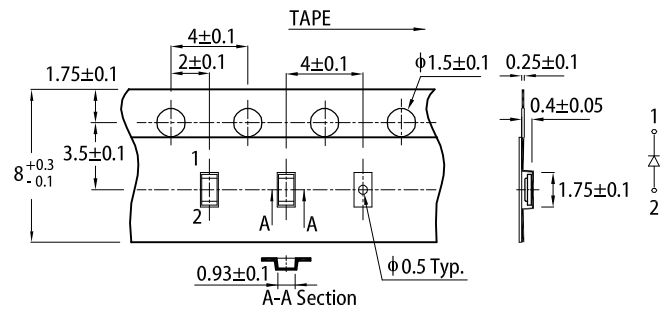
Luminous Intensity vs. Ambient Temperature



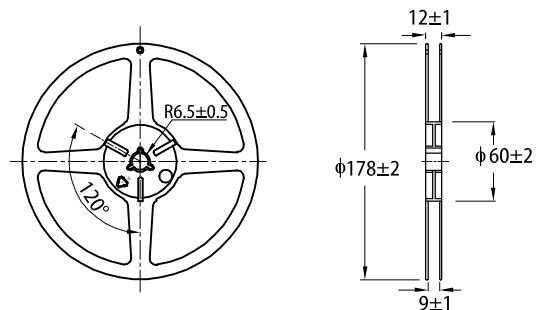
### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

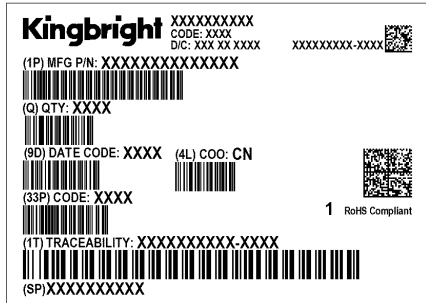
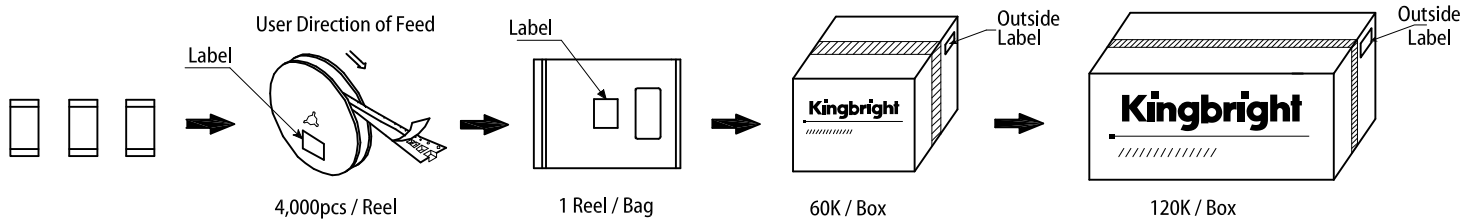


### REEL DIMENSION (units : mm)
